**1.1. Policy Preamble**

This Policy Document is the evidence of the contract between **IndusInd** Nippon Life Insurance Company Limited ( also referred to as “Company”) and the Policyholder. The terms listed in Part B (Definitions) of the Policy Document and used elsewhere in the Policy Document in Initial Capital letters shall have the meaning set out against them in Part B, wherever they appear in the Policy Document.

The Company agrees to pay the Benefits, as stipulated in the Policy to the Claimant on the basis of the statements, Proposal, declarations and Premium along with taxes as applicable from the Policyholder on the assurance that the Policyholder has agreed to all the Policy Terms and Conditions referred in this Policy Document. The Benefits shall be paid as stipulated in the Policy Document. The Claimant needs to submit applicable documents to the Company for claiming the Benefit.

## **2. Part B**

### **2.1. Definitions**

“**Act**” means the Insurance Act, 1938 (4 of 1938), as amended from time to time.

“**Age**” means age as on last birthday; as on the Date of Commencement of Policy or on the previous Policy Anniversary, as the case may be.

“**Annualized Premium**” means the premium amount payable in a year excluding taxes, rider premiums, underwriting extra premiums and loadings for modal premiums.

“**Appointee**” is the person to whom the proceeds/Benefits secured under the Policy are payable if the benefit becomes payable to the Nominee and Nominee is Minor as on the date of claim payment.

“**Assignment**” is the process of transferring the rights and Benefits to an Assignee. Assignment should be in accordance with the provisions of Section 38 of Insurance Act, 1938 as amended from time to time.

“**Assignee**” is the person to whom the rights and Benefits are transferred by an Assignment.

“**Assignor**” means the person who transfers the rights of the life insurance Policy to the Assignee.

“**Attached Paid Up Addition (APUA)**” is the total Paid Up Addition (PUA) in-force in a policy at a given time where PUA is a guaranteed benefit payable at PUA maturity or on death, if earlier.

“**Base Policy / Base Plan/ Base Product/ Policy/ Policy Document**” means this IndusInd Nippon Life Smart Total Advantage Return Policy, which is the evidence of the contract between the Company and the Policyholder.

“**Base Sum Assured**” is the absolute amount of benefit to be paid on maturity or on death, if earlier, for an In-force Policy, as specified in the Policy Schedule.

“**Basis Point**” means one hundredth of one percentage point.

“**Benefit Illustration**” means an Annexure that illustrates the premiums and guaranteed and non-guaranteed Benefits of the proposed Policy.

“**Benefits**” means the Death Benefit, Survival Benefit, Maturity Benefit, Surrender Benefit or any other benefit, as the case may be, as per the terms and conditions of this Policy.

“**Claimant**” means either the Policyholder or the Nominee or the Assignee or the Appointee or the legal heir of the Policyholder / Assignee as the case may be.

In the event of Assignment under this Policy, the Assignee would be entitled to the Benefits under the Policy, subject to Section 38 of Insurance Act, 1938 as amended from time to time.

“**Company/Us/We/Our**” means IndusInd Nippon Life Insurance Company Limited (INLIC).

“**Cash Bonus**” is a non-guaranteed Benefit payable under this policy at the end of each Policy Year, starting from the first Policy Year and is expressed as a percentage of the Base Sum Assured and Attached Paid Up Addition (if applicable). Separate Cash Bonus rates, if any, shall be declared by the Company for Base Sum Assured and Attached Paid Up Addition.

“**Date of Commencement of Policy/ Policy Commencement Date**” means the start date of this Policy as mentioned in the Policy Schedule.

“**Date of Commencement of Risk**” means the date as mentioned in the Policy Schedule from which the insurance Benefits/rider Benefits, if any, start under the Policy.

“**Death Benefit**” means the benefit which is payable on death of Life Assured, as stated in the Policy Document.

“**Free Look Period**” means a period of 30 days beginning from the date of receipt of Policy Document, whether received electronically or otherwise, to review the terms and condition of the Policy. If the Policyholder disagrees to any of the

Policy terms and conditions, or otherwise has not made any claim, he/she shall have the option to return the Policy to the Company for cancellation, stating the reasons for the same.

“**Fully Paid-up Policy**” shall mean policies where all premiums have been paid for the complete Premium Payment Term mentioned in the Policy Schedule.

“**Grace Period**” means the time granted by the Company from the due date for the payment of premium, without any penalty or late fee, during which time the Policy is considered to be In-force with the risk cover without any interruption as per the terms and conditions of the Policy.

“**Guaranteed Loyalty Addition (GLA)**” is equal to GLA rate multiplied by Base Sum Assured for an In-force Policy, payable on survival of Life Assured till the end of Premium Payment Term.

“**In-force/In-force status**” means a condition during the Policy Term, wherein the Policyholder has paid all the due premiums till date under the Policy contract.

“**Instalment Premium**” means the amount stipulated in the Policy Schedule and payable at regular intervals (yearly/half yearly/quarterly or monthly frequency as applicable) by the Policyholder as consideration for acceptance and continuance of risk and Benefits specified as such in the Policy Document.

“**IRDAI / Authority**” means Insurance Regulatory and Development Authority of India.

“**Lapse**” means a condition wherein the due premiums have not been paid in full within the Grace Period and before the Policy has acquired a Surrender Value. No Benefits will be paid when the Policy lapses or is in Lapse status.

“**Life Assured**” means the person, named as such in the Policy Schedule, on whose life, the insurance cover is effected as per the terms & conditions of this Policy.

“**Maturity Benefit**” means Sum Assured on Maturity, any additional and accrued benefit, which is payable on maturity in accordance with the terms and conditions of the Policy.

“**Maturity Date / Policy Maturity Date**” means the date specified in the Policy Schedule on which the Maturity Benefit is due to the Policyholder.

“**Minor**” is a person who has not completed 18 years of age.

“**Nominee**” means the person or persons nominated under Section 39 of the Insurance Act, 1938, as amended from time to time, by the Policyholder, to receive the admissible Benefits, in the event of death of the Life Assured.

“**Nomination**” is the process of nominating a person who is named as “Nominee” in the proposal form or subsequently included/ changed by an Endorsement. Nomination should be in accordance with provisions of Section 39 of the Insurance Act, 1938 as amended from time to time.

“**Paid-up / Reduced Paid-up Benefit**” means the amount payable upon the occurrence of events, as specified under the Plan, when the Policy is in Paid-up Status.

“**Paid-up / Reduced Paid-up Status**” means a condition during the Policy Term, wherein the premiums have been paid in full for at least the first Policy Year, as required under the Plan and the remaining due premiums have not been paid, rendering the Policy to continue at a reduced level of Benefits, as specified under the Plan.

“**Par / Participating / Par products**” or means products where policies are entitled to share in surplus (profits) during the term of the policy as per section 49 of the Act.

“**Policy Anniversary**” means the start date of every subsequent Policy Year and as specified in the Policy schedule.

“**Policy Schedule/Schedule**” means the attached Schedule that provides Your Policy Benefits. The Schedule also includes any amendments to the attached Schedule which may be issued from time to time.

“**Policy Term**” means the entire term of the Policy specified as such in the Policy Schedule.

“**Policy Year**” means a period of 12 consecutive months starting from the Date of Commencement of the Policy as stated in the Policy Schedule and ending on the day immediately preceding the following anniversary date and each subsequent period of 12 consecutive months thereafter.

**“Policyholder/Policy Owner/Proposer/You”** means the person specified as such in the Policy Schedule or such other person, who may become the holder of this Policy in respect of the terms and conditions of this contract or by virtue of operation of law.

**“Premium Payment Term”** means the period or the term of the Policy contract during which the Policyholder is required to pay the premiums with respect to the Policy, to the Company.

**“Regulations”** means the extant laws and regulations that are applicable to this Policy.

**“Revival of a Policy”** means restoration of the Policy, which was discontinued due to the non-payment of Premium, by the Company with all the Benefits mentioned in the Policy Document, with or without rider Benefits if any, upon the receipt of all the Premiums due and other charges or late fee if any, as per the terms and conditions of the Policy, upon being satisfied as to the continued insurability of the Life Assured or Policyholder on the basis of the information, documents and reports furnished by the Policyholder, in accordance with Board Approved Underwriting Policy.

**“Revival Period”** means the period of five consecutive complete years from the date of first unpaid premium.

**“Savings/Savings Products”** means those products other than “Pure Risk Products”.

**“Sum Assured on Death”** means an absolute amount of benefit which is guaranteed to become payable on death of the Life Assured in accordance with the terms and conditions of the Policy.

**“Sum Assured on Maturity”** means an absolute amount of benefit which is guaranteed to become payable at the end of the Policy Term i.e. on maturity of the Policy in accordance with the terms and conditions of the Policy.

**“Surrender”** means the complete withdrawal or termination of the entire Policy contract.

**“Surrender Value/Surrender Benefit”** means an amount that is payable upon complete withdrawal/termination of the Policy by the Policyholder.

**“Survival Benefit”** means the guaranteed and non-guaranteed Benefit payable, as per the terms and conditions of the Policy, until death of the Life Assured or end of the Policy Term, whichever is earlier.

**“Survival Benefit Account (SBA)”** is a separate account in the Policy where Survival Benefits will be accumulated if Accumulation of Survival Benefits is opted under Policy.

**“Total Premiums Paid”** means total of all the premiums paid under the Base Product, excluding any extra premiums and taxes, if collected explicitly.

**“Terminal Bonus”** is a non-guaranteed Benefit payable on Death or Maturity or Surrender as per the terms and conditions of the Policy, provided the same is declared by the Company.

**“Unique identification number (UIN)”** means a unique number allotted to each product which is required to be disclosed in product related literature, Policy Documents and any other supporting documents for such product.

**“Vesting”** means where Life Assured is a minor at the inception of the Policy, the ownership of the Policy shall vest on the Life Assured on attainment of 18 years of Age.

### **3. Part C**

#### **3.1. Key Benefits**

##### **3.1.1. Death Benefit**

###### **3.1.1.1. Life Variant:**

On death of the Life Assured during the Policy Term, provided the Policy is In-force i.e. all due Premiums have been paid as on the date of death, the following Benefits shall be payable immediately to the Claimant(s) as a lumpsum:

Higher of

- Sum Assured on Death Plus, Terminal Bonus, if any, and,
- 105% of Total Premiums Paid as on date of death of the Life Assured.

Plus, Attached PUA, if any

Plus, balance in SBA, if any.

Where, Sum Assured on Death is equal to higher of:

- 11 times the Annualized Premium, and
- Base Sum Assured

Death Benefit for Minor Life:

If Age at entry of the Life Assured is greater than or equal to 8 years, the risk will commence immediately from the Date of Commencement of Policy. If Age at entry of the Life Assured is less than 8 years, the risk under the Policy will commence either from the last day of the second Policy Year or from the Policy Anniversary date falling immediately after attainment of 8 years of age, whichever is earlier. If the Age at entry of the Life Assured is less than 8 years and the death happens before the Date of Commencement of Risk, the Death Benefit shall be restricted to the Total Premiums Paid plus Attached PUA, if any, plus balance in Survival Benefit Account (SBA), if any.

The Policy will terminate on payment of the Death Benefit to the Claimant(s).

###### **3.1.1.2. Life Plus Variant:**

On death of the Life Assured during the Policy Term, provided the Policy is In-force i.e. all due Premiums have been paid as on the date of death, the following Benefits shall be payable immediately to the Claimant(s) as a lumpsum:

Higher of

- Sum Assured on Death , and,
- 105% of Total Premiums Paid as on date of death of the Life Assured

Plus, Attached PUA, if any.

Where, Sum Assured on Death is equal to higher of:

- 11 times the Annualized Premium; and
- Base Sum Assured

On death of the Life Assured, the risk cover under the Policy will terminate. However, the Policy will continue and in addition to above lump sum benefit payable on death, the Claimant will continue to receive the Survival Benefits and Maturity Benefits, as and when due, without requirement to pay future premiums, as would have been the case had the Life Assured been alive and would have been paying the premiums due.

Terminal bonus shall not be payable on death of the Life Assured. It would be payable only on Policy Maturity Date.

PUA option, if opted under the Policy, will terminate on death of the Life Assured and the Attached PUA, if any, shall be paid to the Claimant. Claimant will not have an option to convert future Cash Bonus and GLA, if any, in to PUA.

Accumulation of Survival Benefits option, if active under the Policy as on the date of death of the Life Assured, will continue to remain active after death of Life Assured and the future Cash Bonus and GLA, if any, will continue to accumulate in SBA. However, the Claimant will have the flexibility to opt-in or opt-out of this option anytime during the Policy Term after death of Life Assured. Balance in SBA, if any, will also continue to remain in SBA and the Claimant will have option to withdraw the balance in SBA, fully or partially, anytime during the policy term. The balance in SBA, if any, will be paid at the end of the Policy Term.

The Claimant will not have an option to Surrender the Policy after the death of the Life Assured.

The Policy will terminate on the Policy Maturity Date.

#### 3.1.2. Survival Benefit

##### 3.1.2.1. Cash Bonus (CB):

Cash Bonuses on Base Sum Assured and on Attached Paid Up Addition, if any, at the Cash Bonus rates declared by the Company, shall be payable at the end of each Policy Year starting from the first Policy Year till end of the Policy Term, provided the Policy is In-force i.e. all due premiums have been paid.

Separate Cash Bonus rates, if any, will be declared for Base Sum Assured and Attached Paid Up Addition.

##### 3.1.2.2. Guaranteed Loyalty Addition (GLA):

On survival of the Life Assured till the end of the Premium Payment Term, provided the Policy is In-force i.e. all due premiums have been paid, Guaranteed Loyalty Addition equal to GLA Rate multiplied by Base Sum Assured shall be payable.

Where, GLA Rate is as below:

##### 3.1.2.3. Flexibilities to receive Survival Benefits

###### 3.1.2.3.1. Immediate Payout

The Survival Benefits shall be paid out in the following manner:

Cash Bonus (CB): Cash bonus, if any, declared for the Policy Year shall be paid out to the Policyholder at the end of the Policy Year.

Guaranteed Loyalty Addition (GLA): GLA shall be paid to the Policyholder at the end of the Premium Payment Term.

This will be the default payout option if Accumulation of Survival Benefits or Convert Survival Benefits into PUA is not opted under the Policy.

###### 3.1.2.3.2. Accumulation of Survival Benefits

- Policyholder has an option to accumulate Survival Benefits in a separate Survival Benefit Account (SBA) instead of taking immediate payout of the same.
- Policyholder needs to opt-in for this Accumulation of Survival Benefits option either at Policy inception or by submitting an explicit request to Us, whereby the Survival Benefits when due will be invested in SBA.
- To opt-in or opt-out, Policyholder should submit a written request at least 30 days before the Policy Anniversary and the same will be effective from next Policy Anniversary. This option can be opted-in and opted-out at any number of times during the Policy Term without any charges.

- Under this option, the entire Cash Bonus and GLA payout due for a Policy Year, will be accumulated in the SBA.
- An interest credit rate will be declared on quarterly basis in advance for each quarter by the Company, subject to minimum of State Bank of India savings bank interest rate + 2.00% p.a., and will apply to the SBA under the Policy. For interest credit rate applicable for a quarter, the State Bank of India savings bank interest rate for the lowest deposit slab at the beginning of the preceding quarter will be considered. The Company reserves the right to change the basis of determination of interest rate subject to prior approval of the authority.
- The interest will be credited in the SBA at the end of calendar month.

#### **3.1.2.3.3. Convert Survival Benefits into PUA**

- Policyholder has an option to convert Survival Benefits in to PUA instead of taking immediate payout of the same.
- Policyholder needs to opt-in for this Convert Survival Benefits into PUA option either at Policy inception or by submitting an explicit request to Us, whereby the Survival Benefits when due will be converted to PUA.
- To opt-in or opt-out, Policyholder should submit a written request at least 30 days before the Policy Anniversary and the same will be effective from next Policy Anniversary. This option can be opted-in and opted-out at any number of times during the Policy Term without any charges.
- If this option is opted for, the Survival Benefits i.e., Cash Bonus and Guaranteed Loyalty Addition, will not be paid out to the Policyholder on their due dates and will be converted to Paid Up Addition (PUA) by multiplying with the applicable PUA Conversion Factor. PUA Conversion Factor are given on the Company's website.
- PUA is a guaranteed benefit payable at maturity of PUA or on death of the Life Assured, whichever is earlier.
- PUA will mature and will be paid out as lump sum on the Policy Anniversary immediately following the attainment of Age of 85 years of Life Assured or end of the Policy Term, whichever is earlier.
- The PUA will participate in profits of the Company's With-Profits fund and the same will be distributed by way of Cash Bonuses. Separate Cash Bonus rates, if any, would be declared for the Attached PUAs.
- Surrender of Attached PUA:
  - Attached PUAs can be surrendered separately anytime, partially, or completely, without surrendering the Policy.
  - On such surrender, the Attached PUA benefits will reduce corresponding to the surrendered PUAs.
  - For Surrender Value of PUA, please refer to Section 4.2.
  - In the case of partial surrender of attached PUAs, the minimum Surrender Value of such part surrendered PUA amount should be at least INR 10,000. The company reserves right to modify this limit.

Note: Accumulation of Survival Benefits option and Convert Survival Benefits into PUA option cannot be active simultaneously in a Policy. At a given time during the Policy Term, Policyholder can only opt for any one of these options for future Survival Benefits.

#### **3.1.3. Maturity Benefit**

On survival of the Life Assured to the end of the Policy Term, provided the Policy is In-force i.e. all due premiums have been paid, the following Benefits will be payable:

The Policy will terminate on payment of the Maturity Benefit.

#### **3.1.4. Bonus**

The Policy would participate in the profits by the way of Cash Bonus and Terminal Bonus, if any. Attached Paid Up Addition, if any, will participate in profits of the Company's With-Profits (or Participating) fund and will be distributed by way of Cash Bonuses. The bonuses declared by the Company are not guaranteed and will be based on surplus emerging in With Profits Fund. There are two types of bonus available under the Policy:

1. **Cash Bonus:** Cash Bonus rate, if any, shall be declared annually and shall be payable from the end of the first Policy Year till the end of the Policy Term, provided the Policy is In-force and shall apply to Base Sum Assured and Attached Paid Up Addition, if any.

Separate Cash Bonus rates, if any, shall be declared for Base Sum Assured and Paid Up Addition.

2. **Terminal Bonus:** For Fully Paid-Up Policy, Terminal Bonus shall be payable on maturity and Surrender after the completion of Premium Payment Term. For Life variant, an In-force Policy will be eligible for Terminal Bonus in the event of death of Life Assured or on Surrender if, all due premiums for at least 7 complete Policy Years have been paid for Premium Payment Term of 8 years and 10 years; and all due premiums for at least 10 complete Policy Years have been paid for Premium Payment Term of 12 years and 15 years.

For Life Plus variant, on death of the Life Assured, Terminal Bonus is not payable.

#### **3.1.5. Rider Benefits**

For enhanced protection, the following riders can be purchased with this Policy by paying additional Premiums:

- Accidental Rider (only one from the below):
  - IndusInd Nippon Life Accidental Death Benefit Rider (UIN:121B032V03 or any later version of the rider)
  - IndusInd Nippon Life Accidental Death and Disability Rider (UIN:121B017V03 or any later version of the rider)
  - IndusInd Nippon Life Accidental Death and Disability Plus Rider (UIN:121B016V03 or any later version of the rider)

Under Life Plus variant, IndusInd Nippon Life Accidental Death and Disability Plus Rider cannot be attached to the Base Policy. Rider(s) opted, if any, under Life Plus variant, shall terminate as per the respective rider terms and condition on death of the Life Assured.

- Critical Illness Rider:
  - IndusInd Nippon Life Critical Illness Rider (UIN:121B018V02 or any later version of the rider)

Riders may be selected at the inception of the Policy or on any subsequent Policy Anniversary subject to the Rider Terms and Conditions.

Riders will be offered only where the outstanding Premium Payment Term is at least 5 years. The rider Premium Payment Term cannot be more than the Premium Payment Term of the Base Policy if opted at the inception of the Base Policy or the outstanding Premium Payment Term of the Base Policy, if taken subsequently. Rider premium should be paid along with the premium for the Base Policy on the due date or within the Grace Period. The mode and frequency of rider premium payment shall be same as the mode and frequency of premium payment under the Base Policy.

The attached riders, if any shall Lapse immediately when the Base Policy is Lapsed i.e. where the Policy has not acquired a Surrender value. If the Base Policy is surrendered then attached rider shall terminate immediately and the Surrender

Value/exit value as applicable shall be payable. If the Base Policy moves to Paid up status then the rider may move to Paid up status subject to terms and conditions of the selected rider. If the Base Policy is reinstated, the riders may also be reinstated and all the Terms and Conditions applicable for the Base Policy revival shall also be applicable to the rider reinstatement.

A separate annexure will be provided with the detailed Terms and Conditions of the riders, as and when they are selected by the Policyholder.

#### 3.1.6. Premium details

##### 3.1.6.1. Payment of Premium

The Policyholder is required to pay the Instalment Premiums for the entire Premium Payment Term/ Rider Premium Payment Term as specified in the Policy Schedule and as per terms and conditions of Policy Document.

Premiums shall be considered as paid only when the Premium is received by the Company and an official receipt is issued acknowledging the same.

##### 3.1.6.2. Advance Premium

Collection of renewal premium in advance shall be allowed in this Policy within the same financial year for the Premiums due in that financial year. However, where the premium due in one financial year is being collected in advance in earlier financial year, We may collect the same for a maximum period of 3 months in advance from the due date of the premium. The renewal premium so collected in advance shall only be adjusted on the due date of the premium subject to extant regulatory requirement. In case of advance premium, no interest shall be payable by the Company.

##### 3.1.6.3. Mode of payment of Premium

The modes of premium payment can be by Cash, Cheque, UPI, Debit/Credit Card, ECS/NACH, Online payment, Demand draft, Salary Deduction Scheme (SDS) or Direct Debit or any other as prescribed by Reserve Bank of India/ Company/IRDAI. Quarterly and monthly frequencies of premium payment are allowed only if the premiums are paid electronically such as ECS/NACH. In case the Policyholder has opted for Electronic Clearing System (ECS) or NACH mode for premium payment, the Policyholder shall have the option to withdraw from ECS/NACH mode at least 15 days prior to the premium due date.

##### 3.1.6.4. Premium Payment Frequency

The Policyholder can pay premium either in yearly, half-yearly, quarterly or monthly frequency. When the frequency of payment is half yearly, quarterly or monthly, loading on premium will be applicable as per the table:

The Company, at its sole discretion, may agree to accept the payment of the Premium in any frequency (yearly / half-yearly / quarterly / monthly) as requested by Policyholder.

##### 3.1.6.5. Grace Period for payment of Premium

There is a Grace Period of 30 days (15 days for monthly mode) from the due date of first unpaid premium.

#### **4. Part D**

##### **4.1. Free Look**

You are provided with free look period of 30 days beginning from the date of receipt of Policy Document, whether received electronically or otherwise, to review the terms and conditions stipulated in the Policy Document. In the event You disagree to any of the Policy terms or conditions, or otherwise and have not made any claim, You shall have the option to return the Policy to the Company for cancellation, stating the reasons for the same. You are requested to take appropriate acknowledgement of Your request letter and return of Policy. In which event, the Company will refund the premium paid subject only to a deduction of a proportionate risk premium for the period of cover and the expenses incurred by the Company on the medical examination, if any, and stamp duty charges.

Please note that if the Policy is opted through Insurance Repository ('IR'), the computation of the said Free look Period will be from the date of the email informing Policy credit in IR.

Any request received for Free look cancellation of the Policy shall be processed and premium refunded within 7 days of receipt of the request.

##### **4.2. Surrender Benefit**

The Policy shall acquire a Surrender Value after completion of first Policy Year provided one full year premium has been paid.

###### **Surrender Value is as follows:**

- a. Higher of
  - Guaranteed Surrender Value (GSV), and
  - Special Surrender Value (SSV)

**Plus**

- b. Balance in SBA, if any

**Plus**

- c. Surrender Value of APUA, if any

###### **Guaranteed Surrender Value (GSV) :**

The Policy shall acquire a Guaranteed Surrender Value if all due premiums have been paid for at least first two consecutive Policy Years in full.

Guaranteed Surrender Value is calculated as below:

(GSV Premium Factor multiplied by Total Premium Paid) less Survival Benefits applicable till date, if any, subject to minimum of zero;

GSV Premium Factor are given on the Company's website.

###### **Special Surrender Value (SSV):**

Special Surrender Value shall become payable after completion of first Policy Year provided one full year premium has been paid.

The applicable SSV shall be reviewed annually based on the prevailing yield on 10 Year G Sec and the underlying experience. You are requested to get in touch with Us for the applicable SSV for Your Policy.

###### **Balance in SBA, if applicable**

If the policyholder had opted for Accumulation of Survival Benefits option, the balance in SBA would be payable.

Where,

**Guaranteed Surrender Value of APUA is equal to:**

GSV PUA Factor multiplied by Attached PUA, if any.

GSV PUA Factors are given on the Company’s website.

**Special Surrender Value of APUA:**

The applicable SSV shall be reviewed annually based on the prevailing yield on 10 Year G Sec and the underlying experience. You are requested to get in touch with Us for the applicable SSV for Your Policy.

If the Policy is Surrendered, it cannot be reinstated. The Policy will be terminated once it is surrendered.

**4.3. Discontinuance of payment of premium**

If the Policyholder discontinues the payment of Premiums, the Policy will be treated as Lapsed or Reduced Paid-up.

Kindly refer to the rider terms and conditions for treatment of riders on discontinuance of rider premiums.

**4.3.1. Lapse**

- a. If any Premium remains unpaid after the expiry of the Grace Period and the Policy has not acquired a Surrender Value, the Policy status will be altered to Lapse, the Death Benefit and Rider Benefit, if any, will cease immediately.
- b. The policy will not accrue any bonuses and no Benefits will be payable, when the Policy is in Lapse status.
- c. If a Lapsed Policy is not revived within the Revival Period, the Policy will terminate on expiry of the Revival Period.

**4.3.2. Reduced Paid-up**

- a. If the Policy has acquired a Surrender Value and no future Premiums are paid, the Policy may continue as Reduced Paid-up Policy.  
Cash Bonus on Base Sum Assured, if any, will not be declared after the Policy becomes Reduced Paid-up.

Reduced Paid-up Policy will be eligible for Terminal Bonus on maturity, Surrender, or death if, all due premiums for at least 7 complete Policy Years have been paid for Premium Payment Term of 8 years and 10 years; and all due premiums for at least 10 complete Policy Years have been paid for Premium Payment Term of 12 years and 15 years.
- c. For a Reduced Paid-up Policy, the Benefits under the Policy will be reduced as given below:

#### 4.4. Policy Loan

Loan will be available under a Policy for up to 70% of the applicable Surrender Value (excluding Terminal Bonus, if any, Surrender Value of APUA, if any and Balance in SBA, if any) provided the Policy has acquired a Surrender Value. The interest on loan is payable at the prevailing rate of interest applicable to the loan. The prevailing interest shall be equal to 10-year Benchmark G-sec effective annual yield as on last working day of previous financial year, round-up to the next multiple of 25 Basis Points plus a margin of 150 Basis Points. The rate of interest on loans for FY 24-25 is 8.75% p.a. compounded yearly. Please contact Us to know the prevailing rate of interest for policy loan. The Company reserves the right to change the basis of determination of interest rate and to revise the applicable interest rate less frequently than annual.

For other than In-Force or Fully Paid-up Policy, if at any time during the term of the Policy, the sum of loan outstanding and unpaid interest on loan outstanding exceeds Surrender Value (excluding Surrender Value of APUA, if any and Balance in SBA, if any) at that time; the Policy will be terminated by recovering the loan outstanding amount and unpaid interest amount from the Surrender Value (excluding Surrender Value of APUA, if any and Balance in SBA, if any) after giving intimation and reasonable opportunity to the Policyholder to continue the Policy. The balance of Surrender Value, if any, will be paid to the Policyholder.

For In-Force and Fully Paid-up Policy, the Policy can't be foreclosed on the ground of outstanding loan amount including interest exceeding the Surrender Value.

Before payment of any benefit (Death, Maturity, Survival or Surrender) for a Policy where the loan is availed of, the loan outstanding amount and the interest on loan outstanding will be recovered first and the balance, if any, will be paid to the Claimant/s.

The Claimant will not have an option to avail loan under the Policy after the death of the Life Assured.

#### 4.5. Policy Revival

A Policy in Lapsed or Paid-up condition can be revived within the Revival Period of five years from the due date of first unpaid premium, but before the Policy Maturity Date. The Base Plan along with rider Benefits, if any, can be revived by

On revival, the Policy will be eligible for its complete Benefits as per the original contract; any due and unpaid benefit shall be paid immediately (without any interest) when the Policy is revived.

## **6. Part F**

### **6.1. Alterations**

The premium payment frequency, option to receive Survival Benefit (Immediate Payout / Accumulation of Survival Benefits / Convert Survival Benefits into PUA) can be changed during the Premium Payment Term or Policy Term, as applicable. No other alterations can be made under this Policy.

### **6.2. Claims**

The Company will pay the applicable Death Benefit, Survival Benefit and Maturity Benefits to the Claimant(s) when it is satisfied of the identity of the Claimant(s) and all relevant provisions of the Policy have been met.

In the event of Assignment under this Policy, the Assignee would be entitled to the Benefits under the Policy, subject to Section 38 of Insurance Act, 1938, as amended from time to time, or any further amendments affected by the IRDAI or other appropriate governmental authorities from time to time.

#### **Requirements for Maturity, Survival, Surrender and Death Benefit payout**

To enable the Company to process the Survival and Maturity Benefit in a speedy manner, the Claimant shall endeavour to submit the primary documents at least 15 days before the Policy Maturity Date / Survival Benefit due date.

In the event of a claim for Death Benefit arising under this Policy, the Claimant shall endeavour to intimate the Company in writing of the claim and provide the following documents to the Company preferably within 90 days from the claim event. The Company may ask for additional explanations and documents, justifying the delay from the Claimants intimating the claim beyond the specified period of 90 days.

- b. It shall be the responsibility of the Policyholder to satisfy himself and ensure that the payment of the Additional Premium does not adversely affect his entitlement or claim for tax Benefits, if any, available or admissible under this Policy.

- In case, the correct Age of the Life Assured as on the Date of Commencement of Policy makes Life Assured ineligible for this Policy, we will offer you an alternative plan as per our underwriting norms. If you do not wish to opt for the alternative plan or if it is not possible for us to grant any other plan, then the Company would reserve the right to cancel the Policy immediately as void ab initio and the Premiums paid under the Policy will be returned (without interest) subject to the deduction of expenses incurred by the Company.
- If the age of the Life Assured as on the Date of Commencement of Policy is found to be different from that declared basis declaration made by the Policyholder/Life Assured, but within the age limits of this Policy then:
  - In case the correct age at Policy inception is found to be lower, the Company shall refund the difference in premiums without interest or increase the Benefits which would have been due as per the correct age.

**7.5 Procedure for filing complaint with the Insurance Ombudsman**

While We expect to satisfactorily resolve Your grievances, You may also at any time approach the Insurance Ombudsman. The Insurance Ombudsman may receive and consider any complaints under Rule 13 of the Insurance Ombudsman Rules 2017 (or, as amended from time to time) as described below:

**Duties and functions of Insurance Ombudsman:**

1. The Ombudsman shall receive and consider complaints or alleging deficiency in performance required of an insurer (including its agents and intermediaries) or an insurance broker, on any of the following grounds:
  - a) Delay in settlement of claims, beyond the time specified in the Regulations, framed under the Insurance Regulatory and Development Authority of India Act,1999
  - b) Any partial or total repudiation of claims by the life insurer, General insurer or the health insurer;
  - c) Disputes over premium paid or payable in terms of insurance Policy;
  - d) Misrepresentation of Policy Terms and conditions at any time in the Policy Document or Policy contract;
  - e) Legal construction of insurance policies insofar as the dispute relates to claim;
  - f) Policy servicing related grievances against insurers and their agents and intermediaries;
  - g) Issuance of life insurance Policy, general insurance Policy including health insurance Policy which is not in conformity with the proposal form submitted by the Proposer;
  - h) Non-issuance of insurance Policy after receipt of premium in life insurance and general insurance including health insurance; and
  - i) Any other matter resulting from the violation of provisions of the Insurance Act, 1938, as amended from time to time, or the Regulations, circulars, guidelines or instructions issued by IRDAI from time to time or the terms and conditions of the Policy contract, in so far as they relate to issues mentioned at clauses (a) to (h).

Explanation: For the purpose of this sub-rule, the term ‘deficiency’ shall have the meaning as assigned to it in clause (11) of section of the Consumer Protection Act, 2019 (35 of 2019).

2. The Ombudsman shall act as counsellor and mediator relating to matters specified in sub-rule (1) provided there is written consent of the parties to the dispute.
3. The Ombudsman shall be precluded from handling any matter if he is an interested party or having conflict of interest.
4. The Central Government or as the case may be, the IRDAI may, at any time refer any complaint or dispute relating to insurance matters specified in sub-rule (1), to the Insurance Ombudsman and such complaint or dispute shall be entertained by the Insurance Ombudsman and be dealt with as if it is a complaint made under rule 14.

**Manner in which complaint is to be made**

1. Any person who has a grievance against an insurer or an insurance broker, may himself or through his legal heirs, Nominee or Assignee, make a complaint in writing to the Insurance Ombudsman within whose territorial jurisdiction the branch or office of the insurer or the insurance broker, as the case may be, complained against or the residential address or place of residence of the complainant is located.
2. The complaint shall be in writing, duly signed or made by way of electronic mail or online through the website of the Council of Insurance Ombudsmen, by the complainant or through his legal heirs, Nominee or Assignee and shall state clearly the name and address of the complainant, the name of the branch or office of the insurer against whom

the complaint is made, the facts giving rise to the complaint, supported by documents, the nature and extent of the loss caused to the complainant and the relief sought from the Insurance Ombudsman.

3. No complaint to the Insurance Ombudsman shall lie unless
  - a. the complainant has made a representation in writing or through electronic mail or online through website of the insurer or insurance broker concerned to the insurer or the insurance broker, as the case may be, named in the complaint and
    - i. either the insurer or the insurance broker, as the case may be, had rejected the complaint; or
    - ii. the complainant had not received any reply within a period of one month after the insurer or the insurance broker, as the case may be, received his representation; or
    - iii. the complainant is not satisfied with the reply given to him by the insurer or the insurance broker, as the case may be;
  - b. The complaint is made within one year—
    - i. after the order of the insurer or the insurance broker, as the case may be, rejecting the representation is received; or
    - ii. after receipt of decision of the insurer or the insurance broker, as the case may be, which is not to the satisfaction of the complainant;
    - iii. after expiry of a period of one month from the date of sending the written representation to the insurer or the insurance broker, as the case may be, if the insurer named fails to furnish reply to the complainant.
4. The Ombudsman shall be empowered to condone the delay in such cases as he may consider necessary, after calling for objections of the insurer or the insurance broker, as the case may be, against the proposed condonation and after recording reasons for condoning the delay and in case the delay is condoned, the date of condonation of delay shall be deemed to be the date of filing of the complaint, for further proceedings under these rules.
5. No complaint before the Insurance Ombudsman shall be maintainable on the same subject matter on which proceedings are pending before or disposed of by any court or consumer forum or arbitrator.
6. The Council for Insurance Ombudsmen shall develop a complaints management system, which shall include an online platform developed for the purpose of online submission and tracking of the status of complaints made under rule 14.

The Insurance Ombudsman shall not entertain complaints where the loss suffered by the complainant exceeds Rupees fifty lakhs.

**2. Appendix B: Section 39, Nomination by Policyholder**

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

1. The Policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the Policy shall be paid in the event of his Death.
2. Where the Nominee is a minor, the Policyholder may appoint any person to receive the money secured by the Policy in the event of Policyholder's Death during the minority of the Nominee. The manner of appointment to be laid down by the insurer.
3. Nomination can be made at any time before the maturity of the Policy.
4. Nomination may be incorporated in the text of the Policy itself or may be endorsed on the Policy communicated to the insurer and can be registered by the insurer in the records relating to the Policy.
5. Nomination can be cancelled or changed at any time before Policy matures, by an endorsement or a further endorsement or a will as the case may be.
6. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the Policy or in the registered records of the insurer.
7. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.
8. On receipt of notice with fee, the insurer should grant a written acknowledgement to the Policyholder of having registered a nomination or cancellation or change thereof.
9. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the Policy. The nomination will get revived on repayment of the loan.
10. The right of any creditor to be paid out of the proceeds of any Policy of life insurance shall not be affected by the nomination.
11. In case of nomination by Policyholder whose life is insured, if the Nominees die before the Policyholder, the proceeds are payable to Policyholder or his heirs or legal representatives or holder of succession certificate.
12. In case Nominee(s) survive the person whose life is insured, the amount secured by the Policy shall be paid to such survivor(s).
13. Where the Policyholder whose life is insured nominates his
  - a. parents or
  - b. spouse or
  - c. children or
  - d. spouse and children
  - e. or any of them

the Nominees are beneficially entitled to the amount payable by the insurer to the Policyholder unless it is proved that Policyholder could not have conferred such beneficial title on the Nominee having regard to the nature of his title.

14. If Nominee(s) die after the Policyholder but before his share of the amount secured under the Policy is paid, the share of the expired Nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such Nominee(s).

15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after 26.12.2014 the date when insurance law was amended.
16. If Policyholder dies after maturity but the proceeds and Benefit of the Policy has not been paid to him because of his Death, his Nominee(s) shall be entitled to the proceeds and Benefit of the Policy.
17. The provisions of Section 39 are not applicable to any life insurance Policy to which Section 6 of Married Women’s Property Act, 1874 applies or has at any time applied except where a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the Policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the Policy. In such a case only, the provisions of Section 39 will not apply.

**3. Appendix C: Section 38, Assignment and Transfer of Insurance Policies**

Assignment or transfer of a Policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

1. This Policy may be transferred/assigned, wholly or in part, with or without consideration.
2. An Assignment may be effected in a Policy by an endorsement upon the Policy itself or by a separate instrument under notice to the Insurer.
3. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
4. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
5. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy there of certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.
6. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.
7. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
8. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the Policy is being serviced.
9. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
  - a. not bonafide or
  - b. not in the interest of the Policyholder or
  - c. not in public interest or
  - d. is for the purpose of trading of the insurance Policy.
10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of Policyholder giving a notice of transfer or assignment
11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.
12. The priority of claims of persons interested in an insurance Policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
  - a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR
  - b. where the transfer or assignment is made upon condition that
    - i. the proceeds under the Policy shall become payable to Policyholder or Nominee(s) in the event of assignee or transferee dying before the insured OR
    - ii. the insured surviving the term of the Policy

Such conditional assignee will not be entitled to obtain a loan on Policy or surrender the Policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.

14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
  - a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
  - b. may institute any proceedings in relation to the Policy
  - c. obtain loan under the Policy or surrender the Policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
15. Any rights and remedies of an assignee or transferee of a life insurance Policy under an assignment or transfer effected before 26.12.2014, the date when insurance law was amended, shall not be affected by this section.

**4. Appendix D: Section 45, Policy shall not be called in question on the ground of mis-statement after three years**

Provisions regarding Policy not being called into question in terms of Section 45 of the Insurance Act, 1938, as amended from time to time are as follows:

1. No Policy of Life Insurance shall be called in question **on any ground whatsoever** after expiry of 3 yrs from
  - a. the date of issuance of Policy or
  - b. the Date of Commencement of Risk or
  - c. the date of revival of Policy or
  - d. the date of rider to the Policywhichever is later.
2. On the ground of fraud, a Policy of Life Insurance may be called in question within 3 years from
  - a. the date of issuance of Policy or
  - b. the Date of Commencement of Risk or
  - c. the date of revival of Policy or
  - d. the date of rider to the Policywhichever is later.

For this, the insurer should communicate in writing to the insured or legal representative or Nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based.

3. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance Policy:
  - a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;
  - b. The active concealment of a fact by the insured having knowledge or belief of the fact;
  - c. Any other act fitted to deceive; and
  - d. Any such act or omission as the law specifically declares to be fraudulent.
4. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak, or silence is in itself equivalent to speak.
5. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Insured / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the Policyholder, if alive, or beneficiaries.
6. Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which Policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or Nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the Policy of life insurance is based.
7. In case repudiation is on ground of mis-statement and not on fraud, the premium collected on Policy till the date of repudiation shall be paid to the insured or legal representative or Nominee or assignees of insured, within a period of 90 days from the date of repudiation. However, the payment will be as per IRDAI direction/Regulation/Circular from time to time.
8. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance Policy would have been issued to the insured.

9. The insurer can call for proof of age at any time if he is entitled to do so and no Policy shall be deemed to be called in question merely because the terms of the Policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.
