**1.1. Policy Preamble**

This Policy Document is the evidence of the contract between IndusInd Nippon Life Insurance Company Limited (hereinafter called “Company”) and the Policyholder referred to below. The terms listed in Part B (Definitions) of the Policy Document and which have been used elsewhere in the Policy Document in Initial Capital letters shall have the meaning set out against them in Part B, wherever they appear in the Policy Document.

The Company agrees to pay the Benefits, as stipulated in the Policy to the Claimant on the basis of the statements, Proposal, declarations and Premium along with taxes as applicable from the Policyholder on the assurance that the Policyholder has agreed to all the Policy Terms and Conditions referred to in this Policy Document. The Benefits shall be paid as stipulated in the Policy Document. The Claimant needs to submit applicable documents to the Company for claiming the Benefits.

## **2. Part B**

### **2.1. Definitions**

**“Age”** means Age as of last birthday; i.e. the Age in completed years as on the Date of Commencement of Policy or on the previous Policy Anniversary, as the case may be.

**“Annualized Premium”** means the premium amount payable in a year excluding taxes, rider premiums, underwriting extra premiums and loadings for modal premiums.

**“Assignment”** is the process of transferring the rights and benefits to an Assignee. Assignment should be in accordance with the provisions of Section 38 of Insurance Act, 1938 as amended from time to time.

**“Assignee”** is the person to whom the rights and benefits are transferred by an Assignment

**“Base Policy / Policy / Base Product / Base Plan / Policy Document”** means this IndusInd Nippon Life Milestone Plan Policy, which is the evidence of the contract between the Company and the Policyholder.

**“Base Sum Assured”** is the absolute amount of benefit as chosen by You and as specified in the Policy Schedule

**“Benefit Illustration”** means an Annexure along with the Policy Schedule that illustrates the premiums and guaranteed and non-guaranteed benefits of the proposed Policy.

**“Benefits”** means the Death Benefit, Maturity Benefit, Surrender Benefit or any other Benefit, as the case may be, as per the terms and conditions of this Policy.

**“Claimant”** means either the Life Assured or the Policyholder or the Nominee or the Assignee or the legal heir of the Life Assured / Policyholder Assignee as the case may be.

In the event of assignment under this Policy, the Assignee would be entitled to the Benefits under the Policy, subject to Section 38 of Insurance Act, 1938 as amended from time to time.

**“Company/Us/We/Our”** means IndusInd Nippon Life Insurance Company Limited (INLIC).

**“Compounded Reversionary Bonus”** is calculated as a percentage of the Base Sum Assured and all previously accrued Reversionary bonus (if any).

**“Date of Commencement of Policy”** means the start date of this Policy as specified in the Policy Schedule.

**“Date of Commencement of Risk”** means the date as mentioned in the Policy Schedule from which the insurance Benefits / rider Benefits, (chosen at the time of inception of the policy) if any, start under the Policy

**“Death benefit”** means the benefit which is payable on death of Life Assured or the Proposer, as applicable, as stated in the Policy Document.

**“Free Look Period”** means a period of 30 days beginning from the date of receipt of Policy Document, whether received electronically or otherwise, to review the terms and condition of the Policy. If the Policyholder disagrees to any of the Policy terms and conditions, or otherwise has not made any claim, he/she shall have the option to return the Policy to the Company for cancellation, stating the reasons for the same.

**“Fully Paid-up Policy”** shall mean policies where all premiums have been paid for the complete Premium Payment Term mentioned in Policy Schedule.

**“Grace Period”** means the time granted by the Company from the due date for the payment of Premium, without any penalty or late fee, during which time the Policy is considered to be In-force with the risk cover without any interruption as per the terms and conditions of the Policy.

**“In-force /In-force status”** means a condition during the term of the Policy, wherein the Policyholder has paid all the due Premiums till date under the Policy contract.

**“Instalment Premium”** means the amount of Premium stipulated in the Policy Schedule and paid at regular intervals (yearly/half yearly/quarterly or monthly mode as shall be applicable) by the Policyholder as consideration for acceptance of risk and Benefits specified as such in the Policy Document.

**“Lapse”** means a condition wherein the due Premiums have not been paid in full at the expiry of the Grace Period and before the Policy has acquired a Surrender Value. No Benefits will be paid when the Policy lapses or is in Lapse status.

**“Life Assured”** means the person, named as such in the Policy Schedule, on whose life; the Sum Assured of Death is affected as per the terms of this Policy.

**“Maturity Benefit”** means Sum Assured on Maturity, any additional and accrued benefit, which is payable on maturity in accordance with the terms and conditions of the Policy.

**“Maturity Date / Policy Maturity Date”** means the date specified in the Policy Schedule on which the Maturity Benefit is paid to the Policyholder

**“Minor”** is a person who has not completed 18 years of age

**“Nominee”** means the person or persons nominated under Section 39 of the Insurance Act, 1938, as amended from time to time, by the Policyholder, to receive the admissible Benefits under this Policy, in the event of death of the Life Assured.

**“Nomination”** is the process of nominating a person who is named as “Nominee” in the proposal form or subsequently included/ changed by an endorsement. Nomination should be in accordance with provisions of Section 39 of the Insurance Act, 1938 as amended from time to time

**“Par / Participating / Participating Policies”** means policies entitled to share in surplus (profits) during the term of the policy as per section 49 of the Act.

**“Paid-up Benefit”** means the amount payable upon the occurrence of events, as specified under the Plan, when the Policy is in Paid-up status

**“Paid-up / Reduced Paid-up / Paid-up Status”** means a condition during the Policy Term, wherein the premiums have been paid in full for at least the first Policy Year, as required under the Plan and the remaining due premiums have not been paid, rendering the Policy to continue at a reduced level of Benefits, as specified under the Plan

**“Policy Anniversary”** means the start date of every subsequent Policy Year and as specified in the Policy schedule.

**“Policy Schedule/Schedule”** means the attached Schedule that provides Your Policy Benefits. The Schedule also includes any amendments to the attached Schedule which may be issued from time to time.

**“Policy Term”** means the entire term of the Policy specified as such in the Policy Schedule.

**“Policy Year”** means a period of 12 consecutive months starting from the Date of Commencement of the Policy as stated in the Policy Schedule and ending on the day immediately preceding the following anniversary date and each subsequent period of 12 consecutive months thereafter.

**“Policyholder/Policy Owner/Proposer/You”** means the person specified as such in the Policy Schedule or such other person, who may become the holder of this Policy in respect of the terms and conditions of this contract or by virtue of operation of law.

**“Premium Payment Term”** means the period or the term of the Policy contract during which the Policyholder is required to pay the premiums with respect to the Policy, to the Company.

**“Prevailing rate of interest”** means the applicable rate of interest as declared by the Company from time to time that shall be charged to the Policyholder on specified transactions related to the Policy, as specified under the Policy.

**“Regulations”** means the extant laws and regulations that are applicable to this Policy.

**“Revival of a Policy”** means restoration of the Policy, which was discontinued due to the non-payment of Premium, by the Company with all the benefits mentioned in the Policy Document, with or without rider benefits if any, upon the receipt of all the Premiums due and other charges or late fee if any, during the revival period, as per the terms and

conditions of the Policy, upon being satisfied as to the continued insurability of the Life Assured or Policyholder on the basis of the information, documents and reports furnished by the Policyholder, in accordance with Board approved Underwriting policy.

**“Revival Period”** means the period of five consecutive complete years from the date of first unpaid premium.

**“Savings /Savings Products”** means those products other than “Pure Risk Products”.

**“Sum Assured on Death”** means an absolute amount of benefit which is guaranteed to become payable on death of the Life Assured in accordance with the terms and conditions of the Policy. **“Sum Assured on Maturity”** means an absolute amount of benefit which is guaranteed to become payable at the end of the Policy Term i.e. on maturity of the Policy in accordance with the terms and conditions of the Policy.

**“Surrender”** means the complete withdrawal or termination of the entire policy contract.

**“Surrender Value”** means an amount that is payable upon complete withdrawal/termination of the Policy by the Policyholder.

**“Total Premiums Paid”** means the total of all the premiums received for the Base Product, excluding any extra premiums and taxes, if collected explicitly.

**“Terminal Bonus”** is an amount payable over and above the accrued reversionary bonus (if any) when the policy terminates, provided such a terminal bonus is declared by the Company

**“Vesting”** means where Life Assured is a minor at the inception of the Policy, the ownership of the Policy shall vest on the Life Assured on attainment of 18 years of Age.

### **3. Part C**

#### **3.1. Key Benefits**

##### **3.1.1. Death Benefit**

###### **3.1.1.1. On Death of the Life Assured under Life Option and Life Plus Option**

On death of the Life Assured during the Policy Term, provided the Policy is In-force as on the date of death i.e. all due Premiums have been paid, the Claimant will receive higher of:

- Sum Assured on Death plus accrued Compounded Reversionary Bonus plus Terminal Bonus (if any) or
- 105% of Total Premiums Paid up to the date of death of the Life Assured

Where, Sum Assured on Death is higher of:

- Base Sum Assured; or
- Sum Assured on Maturity; or
- Multiple of Annualized Premium as per below table:

<b>Entry Age of Life Assured→ / Premium Payment Term ↓</b>	<b>Less than 50 years</b>	<b>50 years to 55 years</b>	<b>Greater than 55 years</b>
5/6/7/8	11 Times	5 Times	5 Times
10/12/15	11 Times	11 Times	5 Times

Sum Assured on Maturity is equal to the Base Sum Assured under this Policy.

###### **Death Benefit for Minor Life:**

If Age at entry of the Life Assured is greater than or equal to 8 years, the risk will commence immediately from the Date of Commencement of Risk. If the Age at entry of Life Assured is less than 8 years, the risk under the Policy will commence either from the last day of the second Policy Year or from the Policy Anniversary date falling immediately after attainment of 8 years of age, whichever is earlier. If the Age at entry of Life Assured is less than 8 years and the death happens before the Date of Commencement of Risk, the Death Benefit shall be restricted to the Total Premiums Paid.

On payment of Death Benefit of the Life Assured, the Policy shall terminate, and no other Benefits will be payable.

###### **3.1.1.2. On Death of the Proposer under Life Plus Option**

On death of the Proposer during the Premium Payment Term, all future Premiums shall be waived off under the Base Policy, provided the Policy is In-force i.e. all due Premiums have been paid as on the date of death. The Policy shall continue with all the Benefits as applicable on the Life Assured.

##### **3.1.2. Maturity Benefit**

On survival of the Life Assured till the end of the Policy Term, provided the Policy is In-force and all due Premiums have been paid, the aggregate of the following Benefits will be payable:

- Sum Assured on Maturity
- Accrued Compounded Reversionary Bonus (if any)
- Terminal Bonus (if any)

On payment of Maturity Benefit, the Policy shall terminate, and no other Benefits will be payable.

**3.1.2.1. Bonus**

Compounded Reversionary Bonus (if any) shall be declared annually and shall apply as a percentage of the Base Sum Assured and accrued Reversionary Bonus. Once declared they form part of the guaranteed benefits under this policy.

Compounded Reversionary bonus once declared shall accrue to the Policy provided the Policy is not in Lapse or Paid-up Status.

For policies with Policy Term of 10, 11, 12, 13, 14, and 15 years, Terminal Bonus (if any) shall be payable on maturity, death and surrender after completion of Premium Paying Term, provided Policy is fully Paid-up, i.e. all due premiums till the end of Premium Paying Term have been paid. For policies with Policy Term of 17, 19, 20 and 22 years, Terminal Bonus (if any) shall be payable on maturity, death and surrender post end of 10<sup>th</sup> Policy Year, provided all due premiums have been paid till the end of 10<sup>th</sup> Policy Year i.e. from 11<sup>th</sup> Policy Year onwards.

Please note that Reversionary Bonus and Terminal Bonus (if any) are not guaranteed benefits and will vary depending on Company's experience.

**3.1.2.2. Settlement Option:**

On maturity of In-force or Paid-up Policy, You may choose the Settlement Option to convert a part or whole of the Maturity Benefit into a stream of payments. In case You opt for the Settlement Option, We will make the payouts in the following manner and the Policy will terminate on payment of final instalment. The Settlement Option shall be subject to the following terms and conditions:

- You have the flexibility to decide the Settlement Benefit Amount (i.e., proportion of Your Maturity Benefit payable in instalments under the Settlement Option).
- The Maturity Benefit less the chosen Settlement Benefit Amount will be payable as a lump sum at Policy Maturity Date. You may choose a Settlement Benefit Period of 5, 10 or 15 years. The Settlement Benefit Period, once chosen, cannot be altered at a later date.
- You may choose to receive the Settlement Benefit Amount as - "Regular Income" in annual, half-yearly, quarterly or monthly frequencies in arrears, subject to a minimum Regular Income of Rs 5000.
- Change of Regular Income frequency is allowed on subsequent Policy Anniversary after the commencement of Settlement Option.
- The Regular Income will be derived based on the Settlement Benefit Amount, Settlement Benefit Period, the Regular Income frequency opted for and the Settlement Benefit Base Rate prevailing at the time of Policy maturity (refer to table below on "Calculation of Regular Income" and Annexure B for more details).
- The Settlement Option will not be available if the prevailing 10-Year Benchmark G-Sec yield is below 4.16%. In such a case, the maturity benefit will be paid out as a lump sum amount.
- The Regular Income will remain fixed throughout the Settlement Benefit Period and no bonus shall accrue during the Settlement Benefit Period.
- There is no life insurance cover during the Settlement Benefit Period. In case of death of the Life Assured during the Settlement Benefit Period, the Nominee will have the option of continuing to receive the Regular Income as before or receive the discounted value of the remaining Regular Income(s). The discount rate shall be equal to the revival interest rate used by the Company from time to time. On such payment, the Policy will terminate.
- Policy loan will not be available during the Settlement Benefit Period. At any time during the Settlement Benefit Period but at least three months prior to the next Policy Anniversary, the Policyholder may request for full withdrawal of the remaining Regular Income(s). On such request, We will pay the discounted value of the remaining Regular Income(s). The discount rate shall be equal to the prevailing revival interest rate. On such payment, the Policy will terminate.
- Settlement Option will not be applicable for Surrendered policies.

- For policies opting for Settlement Option, the “Prevailing 10-year Benchmark G-Sec Interest Rate” will be the rate on the first working day of the quarter preceding the calendar quarter in which the Policy Maturity Date falls.
- Settlement Benefit Base Rate shall be rounded down to the nearest 25 bps before determining the Regular Income payable.
- Instalment Frequency Factor will be 1 (Annual), 2 (Half-yearly), 4 (Quarterly) & 12 (Monthly).
- The Illustrative Conversion Rates are provided as Annexure B.

**3.1.3. Rider Benefits**

For enhanced protection, the following riders can be purchased with this Policy by paying additional Premiums:

Accidental Rider (any one from the below):

1. IndusInd Nippon Life Accidental Death Benefit Rider (UIN:121B032V03 or any later version of the rider)
2. IndusInd Nippon Life Accidental Death and Disability Rider (UIN:121B017V03 or any later version of the rider)
3. IndusInd Nippon Life Accidental Death and Disability Plus Rider (UIN:121B016V03 or any later version of the rider)

Critical Illness Rider:

1. IndusInd Nippon Life Critical Illness Rider (UIN:121B018V02 or any later version of the rider)

IndusInd Nippon Life Accidental Death and Disability Plus Rider: (UIN: 121B016V03) will not be available under Life Plus option.

Riders may be selected at the inception of the Policy or on any subsequent Policy Anniversary subject to the rider terms and conditions.

Riders will be offered only where the outstanding Premium Payment Term is at least 5 years. The rider Premium Payment Term cannot be more than the Premium Payment Term of the Base Policy if opted at the inception of the Base Policy or will be equal to the outstanding Premium Payment Term of the Base Policy, if taken subsequently. Rider premium should be paid on the due date or within the Grace Period along with the premium for the Base Policy. The mode and frequency of rider premium payment shall be same as the mode and frequency of premium payment under the Base Policy.

The attached riders (if any) shall get lapsed immediately when the Base Policy is lapsed i.e. where the Policy has not acquired a Surrender value. If the Base Policy is surrendered or forfeited then attached rider shall terminate immediately and the Surrender Value/exit value as applicable shall be payable. If the Base Policy moves to Paid up status then the rider may move to Paid up status subject to terms and conditions of the selected rider. If the Base Policy is reinstated,

the riders may also be reinstated and all the terms and conditions applicable for the Base Policy revival shall also be applicable to the rider reinstatement.

A separate annexure will be provided with the detailed terms and conditions of the riders, as and when they are selected by the Policyholder.

### **3.2. Premium details**

#### **3.2.1. Payment of Premium**

The Policyholder/Proposer is required to pay the Instalment Premiums for the entire Premium Payment Term/Rider Term as specified in the Policy Schedule and as per terms and conditions of Policy Document.

Premiums shall be considered as paid only when the Premium is received by the Company and an official receipt is issued acknowledging the same.

#### **3.2.2. Advance Premium**

Collection of renewal premium in advance shall be allowed in this Policy within the same financial year for the premiums due in that financial year. However, where the premium due in one financial year is being collected in advance in earlier financial year, We may collect the same for a maximum period of 3 months in advance of the due date of the premium. The renewal premium so collected in advance shall only be adjusted on the due date of the premium subject to extant regulatory requirements. In case of advance premium, no interest shall be payable by the Company.

#### **3.2.3. Mode of payment of Premium**

The modes of premium payment can be by cash, cheque, UPI, debit/credit card, ECS (Electronic Clearing System)/NACH (National Automated Clearing House), online payment, demand draft, Salary Deduction Scheme (SDS) or direct debit or any other as prescribed by the Reserve Bank of India / Company / IRDAI. Quarterly and monthly frequencies of premium payment are allowed only if the premiums are paid electronically, like through ECS/NACH.

In case the Policyholder has opted for Electronic Clearing System (ECS) or NACH mode for premium payment, the Policyholder shall have the option to withdraw from ECS/NACH mode at least 15 days prior to the premium due date.

#### **3.2.4. Premium Payment Frequency**

The Policyholder can pay premium either in yearly, half-yearly, quarterly or monthly frequency. When the frequency of payment is half yearly, quarterly or monthly, loading on premium will be applicable as per the table:

Frequency	Yearly	Half- yearly	Quarterly	Monthly
Frequency loading	Nil	1%	2%	4%

The Premium Payment Frequency has to be selected at inception. Policyholder has the flexibility to change the Premium Payment Frequency on any Policy Anniversary up to one year before completion of the Premium Payment Term.

The Company, at its sole discretion, may agree to accept the payment of the Premium in any frequency (yearly / half-yearly / quarterly / monthly) as requested by Policyholder. The amended Schedule notifying the changed Installment Premium shall be issued to the Policyholder.

**3.2.5. Grace Period for payment of Premium**

There is a Grace Period of 30 days (15 days for monthly mode) from the due date of first unpaid premium. During the Grace Period the Policy shall remain In-force. In case of a valid claim arising during the Grace Period, but before the payment of due premium, the Company shall honor the claim. In such cases, the due and unpaid premium for the Policy Year will be deducted from any benefit payable.

## **4. Part D**

### **4.1. Free look**

You are provided with free look period of 30 days beginning from the date of receipt of Policy Document, whether received electronically or otherwise, to review the terms and conditions stipulated in the Policy Document. In the event You disagree to any of the Policy terms or conditions, or otherwise and have not made any claim, you shall have the option to return the Policy to the Company for cancellation, stating the reasons for the same. You are requested to take appropriate acknowledgement of Your request letter and return of Policy. Irrespective of the reasons mentioned, the Company shall refund the premium paid subject only to a deduction of a proportionate risk premium for the period of cover, if any and the expenses incurred by the Company on the medical examination, if any, and stamp duty charges. The Policy shall terminate on Free Look cancellation.

Please note that if the Policy is opted through Insurance Repository ('IR'), the computation of the said Free look Period will be from the date of the email informing Policy credit in IR.

### **4.2. Any request received for Free look cancellation of the Policy shall be processed and premium refunded within 7 days of receipt of the request. Policy Loan**

Loan will be available under a Policy for up to 70% of the applicable Surrender Value under the Base Plan after the Policy acquires a Surrender Value. The interest on loan is payable at the prevailing rate of interest of 8.75% p.a. compounded yearly for FY 24-25. Prevailing interest shall be equal to 10 year G-sec benchmark interest rate as on last working day of previous financial year, rounded up to the nearest multiple of 25 basis points plus a margin of 150 basis points. The Company can be contacted to know the prevailing rate of interest for policy loan. The Company reserves the right to revise the applicable interest rate less frequently than annual.

For a Paid-up Policy, if at any time during the term of the Policy, the sum of loan outstanding and unpaid interest on loan outstanding exceeds the Surrender Value at that time; the Policy will be terminated by recovering the loan outstanding amount and unpaid interest amount from the Surrender Value after giving intimation and reasonable opportunity to the Policyholder to continue the Policy.

For In-Force and fully Paid-up Policy, the Policy can't be foreclosed on the ground of outstanding loan amount including interest exceeds the Surrender Value.

Before payment of any Benefit (Death, Maturity, Surrender etc.) to the Policyholder for a Policy where the loan is availed of, the loan outstanding amount and the interest on loan outstanding will be recovered first and the balance, if any, will be paid to the Claimant/s.

### **4.3. Surrender Benefit**

The Policy shall acquire a Surrender Value after completion of first Policy Year provided one full year premium has been paid.

The Surrender Value payable is higher of the Guaranteed Surrender Value and Special Surrender Value.

In case of Life Plus Option, on death of the Proposer, the Policy can be surrendered only when the Life Assured becomes a major.

#### **o Guaranteed Surrender Value (GSV)**

The Policy shall acquire a Guaranteed Surrender Value if all due premiums have been paid for at least first two consecutive Policy Years in full.

Guaranteed Surrender Value = ('GSV Premium Factor' multiplied by 'Total Premiums Paid') plus ('GSV Bonus Factor' multiplied by Accrued Bonus as on the date of Surrender, if any)

GSV factors are provided in Annexure A.

#### **o Special Surrender Value (SSV)**

Special Surrender Value shall become payable after completion of first Policy Year provided one full year premium has been paid.

The applicable SSV shall be reviewed annually based on the prevailing yield on 10 Year G Sec and the underlying experience. You are requested to get in touch with Us for the applicable SSV for Your Policy.

If the Policy is Surrendered, it cannot be reinstated. The Policy will be terminated once it is surrendered.

**4.4. Discontinuance of payment of premium**

If the Policyholder discontinues the payment of Premiums, the Policy will be treated as Lapsed or Paid-up

- a. If any Premium remains unpaid after the expiry of the Grace Period and the Policy has not acquired a Surrender Value, the Policy status will be altered to Lapse status, the Death Benefit and Rider Benefit, if any, will cease immediately
- b. No Benefits will be payable when the Policy is in Lapse status
- c. If a Lapsed Policy is not revived within the Revival Period, the Policy will terminate on expiry of the Revival Period. No benefit is payable on termination of a Lapsed Policy.
- d. If the Policy has acquired a Surrender Value and no future Premiums are paid, the Policy may continue as Reduced Paid-up Policy.
- e. Kindly refer to the rider terms and conditions for treatment of riders on discontinuance of rider premiums.
- f. For a Reduced Paid-up Policy, the Benefits under the Policy will be reduced as given below:

Reversionary Bonuses will not accrue once the Policy becomes Paid-up.

**Reduced Paid-up Death Benefit:**

**Life Option/Life Plus Option:**

On death of the Life Assured during the Policy Term, the Claimant will receive:

- Sum Assured on Death Multiplied by Paid-up Factor) plus
- Accrued Compounded Reversionary Bonus (if any), as on the date of the Policy becoming Paid-up plus
- Terminal Bonus (if any)

The Reduced Paid-up Death Benefit is subject to a minimum of 105% of Total Premiums Paid up to the date of death of the Life Assured.

Once the Policy becomes Reduced Paid-up, the future premiums will not be waived on death of Proposer. However, the policy will continue with reduced paid-up death and maturity benefits on the Life Assured for the remaining Policy Term.

**Reduced Paid-up Maturity Benefit:**

On survival of the Life Assured to the end of the Policy Term, the aggregate of the following benefits will be payable:

- Sum Assured on Maturity multiplied by Paid-up Factor
- Accrued Compounded Reversionary Bonus (if any), as on the date of the Policy becoming Paid-up
- Terminal Bonus (if any)

Where Paid-up Factor = 
$$\frac{\text{Number of Premiums paid}}{\text{Number of Premiums payable during the Premium Payment Term}}$$

Reversionary Bonus will not accrue once the Policy becomes Paid-up.

For Reduced Paid-up Policies with Policy Term of 10 years, the Company may, at its discretion, declare Terminal Bonus (if any) that shall be payable on death, maturity or on Policy surrender from 7<sup>th</sup> Policy Year onwards.

Similarly, for Reduced Paid-up Policies with Policy Term of 11, 12, 13, 14, 15, 17, 19, 20 or 22 years, the Company may, at its discretion, declare Terminal Bonus (if any) that shall be payable on death, maturity or on Policy surrender from 11<sup>th</sup> Policy Year onwards.

#### **4.5. Policy Revival**

A Policy in Lapsed or Paid-up condition can be revived within five years from the due date of first unpaid Premium, but before the Policy Maturity Date. The Policy along with the rider Benefits (if any) can be revived by paying the arrears of Premiums along with the applicable interest.

The Revival of the Policy and riders, if any, will be subject to Company's Board approved underwriting Policy.

The interest for Revival is payable at the Prevailing rate of interest as declared by the Company from time to time. Prevailing interest shall be equal to 10 year G-sec benchmark interest rate as on last working day of previous financial year, rounded up to the nearest multiple of 25 basis points plus a margin of 150 basis points, subject to a minimum revival interest rate of 7.5% p.a. For revival, the rate of interest is 8.75% p.a. compounded yearly for FY 24-25. The Company reserves the right to revise the applicable interest rate less frequent than annual subject to prior approval of the Authority. The revival of the Policy will be subject to Company's Board approved underwriting policy. Under Life Plus Option, both Life Assured and Proposer would be underwritten as per Board approved underwriting policy.

On Revival, the Policy would be eligible for its complete Benefits as per the original contract; any due and unpaid benefit shall be paid immediately (without any interest) when the Policy is revived.

If a Lapsed policy is not revived within the Revival Period, then the policy will be terminated at the end of the Revival Period.

## **6. Part F**

### **6.1. Alterations**

The premium payment frequency can be changed during the Premium Payment Term on Policy Anniversary. No other alterations can be made under this Policy.

### **6.2. Treatment of Minor Life Assured**

In case of minor Life Assured, where the age at entry is less than 8 years, the risk cover will commence under the Policy either from the last day of the second Policy Year or from the Policy Anniversary date falling immediately after attainment of 8 years of age, whichever is earlier. For other cases, the risk cover will commence immediately from the inception of the Policy.

For Policies where the Life Assured is a minor, the Policyholder can be any individual with insurable interest on the life of the Life Assured. The ownership of the Policy shall vest on the Life Assured on attainment of 18 years of Age.

### **6.3. Claims**

The Company will pay the Death and Maturity Benefits to the Claimant when it is satisfied of the identity of the Claimant and all relevant provisions of the Policy have been met.

In the event of assignment under this Policy, the Assignee would be entitled to the Benefits under the Policy, subject to Section 38 of Insurance Act, 1938 as amended from time to time or any further amendments effected by the IRDAI or other appropriate government authorities from time to time

### **6.4. Requirements for maturity, surrender and death claim**

To enable the Company to process the Maturity Benefits in a speedy manner, the Policyholder shall endeavour to submit primary documents at least 15 days before the Maturity Date.

In the event of a claim for Death Benefit arising under this Policy, the Claimant shall endeavour to intimate the Company in writing of the claim and provide the following documents to the Company preferably within 90 days from the claim event. The Company may ask for additional explanations and documents, justifying the delay from the claimants intimating the claim beyond specified period.

- a. Original Policy Schedule
- b. Death certificate in original issued by the competent authority
- c. Hospitalization documents (discharge summary along with all investigation reports) if the Life Assured/Proposer has taken treatment for illness leading to his death
- d. Claim Forms to be filled in by the Claimant; the last treating doctor (if applicable) and by a third person (who is not a relative of the Claimant)
- e. KYC documents of the Claimant as per the Anti Money Laundering (AML) Policy of the Company
- f. Personalized Cancelled cheque leaf/ Self-attested passbook copy of the Claimant/ Bank Statement with last 6 months transaction
- g. Bank Authorization Form
- h. Overseas Claims form (A), Copy of Passport, Embassy Document, Cremation certificate, Body transfer certificate from police officials (Only if Life Assured is nonresident of India)
- i. FATCA CRS Form

- a. First Information Report

The Company reserves the right to call for any additional / other document which may be relevant, including documents/ information concerning the title of the person claiming Benefits under this Policy, as may be required by the Company.

In the event of an act of God and other such extraneous circumstances where the relevant documents are not submitted by the Policyholder / Claimant due to reasons beyond the control of The Policyholder/ Claimant, the Company may process the claim provided there are valid reasons for the non-submission of the relevant documents and it is satisfied on the genuineness of the claim.

**6.5. Suicide Exclusion**

In case of death the Life Assured due to suicide within 12 months from the Date of Commencement of Risk under the Policy or from the date of revival of the Policy, the nominee or beneficiary of the Policyholder shall be entitled to at least 80% of Total Premiums Paid till the date of death or the surrender value available as on the date of death, whichever is higher, provided the Policy is In-force with full or reduced benefits and the Policy will terminate.

**6.6. Tax Benefit**

Premiums paid under Base Policy and Rider(s) opted for, if any, may be eligible for income tax exemptions, subject to the applicable income tax laws and conditions. Income tax Benefits under this Policy and rider Benefits, if opted for

shall be as per the prevailing Income Tax Laws and are subject to amendments and interpretations from time to time. Kindly consult a tax expert.

**6.7. Taxes, duties and levies and disclosure of information**

- a. In the event where the Company is obliged to disclose information concerning to the Policy and Benefits statutory authorities for any taxes, duties, levies or imposts including without limitation any sale, use, value added, Goods and Services Tax (GST) or other taxes, as may be imposed now or in future by any Regulated Authority (collectively “Taxes”) applicable to this Policy or the Benefits payable under this Policy, the Company shall be entitled to disclose such information / deduct such Taxes / pay any amount under the policies and deposit the amount so deducted or directed, with the appropriate governmental or regulatory authorities without informing the Policyholder, if so directed by the authority.
- b. It shall be the responsibility of the Policyholder to satisfy himself and ensure that the payment of the Additional Premium does not adversely affect his entitlement or claim for tax Benefits, if any, available or admissible under this Policy.

**6.8. Nomination**

Nomination should be in accordance with provisions of sec 39 of the Insurance Act 1938 as amended from time to time. [A Leaflet containing the simplified version of the provisions of Section 39 is enclosed in Appendix – B for reference]

**6.9. Assignment**

Assignment should be in accordance with provisions of sec 38 of the Insurance Act 1938 as amended from time to time. [A Leaflet containing the simplified version of the provisions of Section 38 is enclosed in Appendix – C for reference]  
Assignment will not be permitted if the Policy is issued under Married Women’s Property Act, 1874.

**6.10. Proof of Age**

The Age of the Policyholder/Life Assured has been admitted on the basis of the declaration made by the Policyholder/ Life Assured in the Proposal and/or in any statement based on which this Policy has been issued.

- In case, the correct Age of the Policyholder/Life Assured as on the Date of Commencement of Policy makes Policyholder/Life Assured ineligible for this Policy, we will offer you an alternative plan as per our underwriting norms. If you do not wish to opt for the alternative plan or if it is not possible for us to grant any other plan, then the Company would reserve the right to cancel the Policy immediately as void ab initio and the Premiums paid under the Policy will be returned (without interest) subject to the deduction of expenses incurred by the Company.
- If the Age of the Policyholder/Life Assured is found to be different from that declared but within the Age limits of the Policy then:
  - In case the correct Age is found to be lower, the Company shall refund the difference in premiums without interest or increase the Benefits which would have been due as per the correct Age.
  - In case the correct Age is found to be higher, the Company shall intimate the Policyholder to pay the difference in premiums along with the applicable interest from Inception or shall reduce the Policy Benefits which would have been due as per the correct Age.

**6.11. Special provisions**

Any special provisions subject to which this Policy has been entered into, whether endorsed in the Policy or in any separate instrument shall be deemed to be part of the Policy and shall have effect accordingly.

- The Insurance Act, 1938, as amended from time to time.
- Amendments, modifications (including re-enactment) as may be made from time to time, and
- Other such relevant Regulations, Rules, Laws, Guidelines, Circulars, Enactments etc as may be introduced by Life Insurance Council, IRDAI or any other regulatory body with jurisdiction there under from time to time.

We reserve the right to require submission of such documents and proof at all life stages of the Policy as may be necessary to meet the requirements under Anti- money Laundering/Know Your Customer norms and as may be laid down by IRDAI and other regulators from time to time.

**6.12. Recovery of additional expenses incurred on account of acts of Policyholders**

The Company also reserves the right to recover "cheque bounce charges" or "electronic debit bounce charges", incurred by it from the Policyholders, on account of dishonour of cheque issued or bounce of electronic debit towards premium payment, by Policyholders. The Company may recover these additional costs by requisitioning additional payments from the Policyholders.

**6.13. Mode of payment of Benefits**

All Benefits (claims/ maturity payments/ any other sum due to the Policyholders or Nominees or Assignees) under this Policy shall be remitted only through Electronic Clearing System (ECS), National Electronic Fund Transfer (NEFT), Real Time Gross Settlement (RTGS), Interbank Mobile Payment Service (IMPS), National Automated Clearing House (NACH) or any other electronic mode as permitted by Reserve Bank of India.

All Benefits under this Policy shall be payable in the manner and currency allowed / permitted under the Regulations. All amounts payable either to or by the Company and shall be payable in Indian currency.

**6.14. Valid discharge**

Any discharge given by the Claimant, or by any person authorized by the Claimant, in writing, in respect of the Benefits payable under this Policy shall constitute a valid discharge to the Company in respect of such payment. The Company's liability under the Policy shall be discharged by such payment and the Company shall not be required to see the application of the monies so paid.

**6.15. Limitation of liability**

The maximum liability of the Company under this Policy shall not, in any circumstances, exceed the aggregate amount of the relevant Benefits payable hereunder.

**6.16. Fraud Misstatement of a Material Fact and Forfeiture**

In the event of a fraud, the Policy shall be cancelled immediately, and all the premiums paid till date shall be forfeited, subject to fraud being established as per Section 45 of the Insurance Act, 1938, as amended from time to time. In the event of a misstatement or suppression of a material fact, not amounting to fraud, by the insured, the Policy shall be declared "Null and Void" and premiums paid shall be refunded after deducting applicable charges, if any, subject to misstatement or suppression of fact being established, in accordance with Section 45 of the Insurance Act, 1938, as amended from time to time. (Please refer to the simplified version of the provisions of Section 45 as mentioned in Appendix D for reference).

**6.17. Loss of Policy Document**

If the Policy Document is lost or misplaced, you should submit to Us a written request stating the fact and the reason for the loss. We reserve the right to undertake such investigations into and call for such evidence of the loss or destruction of the Policy Document at Your expense as We consider necessary before issuing a copy of the Policy Document. If We are satisfied that the Policy Document is lost or destroyed, then, we will issue a duplicate Policy Document duly endorsed to show that it is issued following the loss or destruction of the original Policy Document. Upon the issue of

You agree to indemnify Us and hold Us free and harmless from any costs, expenses, claims, awards, misuse or judgments arising out of or in relation to the original Policy Document. We may also require You to issue a newspaper declaration for the same. The cost for the same will be borne by You.

**6.18. Waiver**

Failure or neglect by either party to enforce at any time the provisions of this Policy shall not be construed or be deemed to be waiver of either party's right here in nor in anyway affect the validity of the whole or any part of this Policy nor prejudice either party's right to take subsequent action.

**6.19. Electronic transaction**

The Policyholder shall adhere to and comply with all such terms and conditions as prescribed by the Company from time to time and hereby agree and confirm that all transactions effected by or through facilities for effecting remote transactions including the Internet, World Wide Web, electronic data interchange, call centres, tele-service operations (whether voice, video, data or combination thereof) or by means of electronic, computer, automated machines network or through other means of telecommunication, established by or on behalf of the Company, for and in respect of the Policy or its terms, or the Company other products and services, shall constitute legally binding and valid transactions when done in adherence to and in compliance with the Company's terms and conditions for such facilities, as may be prescribed from time to time.

#### **7.5. Procedure for filing complaint with the Insurance Ombudsman**

While We expect to satisfactorily resolve Your grievances, You may also at any time approach the Insurance Ombudsman. The Insurance Ombudsman may receive and consider any complaints under Rule 13 of the Insurance Ombudsman Rules 2017 (or, as amended from time to time) as described below:

##### **Duties and functions of Insurance Ombudsman:**

1. The Ombudsman shall receive and consider complaints or alleging deficiency in performance required of an insurer (including its agents and intermediaries) or an insurance broker, on any of the following grounds:
  - a) Delay in settlement of claims, beyond the time specified in the Regulations, framed under the Insurance Regulatory and Development Authority of India Act, 1999
  - b) Any partial or total repudiation of claims by the life insurer, General insurer or the health insurer;
  - c) Disputes over premium paid or payable in terms of insurance Policy;
  - d) Misrepresentation of Policy Terms and conditions at any time in the Policy Document or Policy contract;
  - e) Legal construction of insurance policies insofar as the dispute relates to claim;
  - f) Policy servicing related grievances against insurers and their agents and intermediaries;
  - g) Issuance of life insurance Policy, general insurance Policy including health insurance Policy which is not in conformity with the proposal form submitted by the Proposer;
  - h) Non-issuance of insurance Policy after receipt of premium in life insurance and general insurance including health insurance; and
  - i) Any other matter resulting from the violation of provisions of the Insurance Act, 1938, as amended from time to time, or the Regulations, circulars, guidelines or instructions issued by IRDAI from time to time or the terms and conditions of the Policy contract, in so far as they relate to issues mentioned at clauses (a) to (h).

Explanation: For the purpose of this sub-rule, the term ‘deficiency’ shall have the meaning as assigned to it in clause (11) of section of the Consumer Protection Act, 2019 (35 of 2019).

2. The Ombudsman shall act as counsellor and mediator relating to matters specified in sub-rule (1) provided there is written consent of the parties to the dispute.
3. The Ombudsman shall be precluded from handling any matter if he is an interested party or having conflict of interest.
4. The Central Government or as the case may be, the IRDAI may, at any time refer any complaint or dispute relating to insurance matters specified in sub-rule (1), to the Insurance Ombudsman and such complaint or dispute shall be entertained by the Insurance Ombudsman and be dealt with as if it is a complaint made under rule 14.

##### **Manner in which complaint is to be made**

1. Any person who has a grievance against an insurer or an insurance broker, may himself or through his legal heirs, Nominee or Assignee, make a complaint in writing to the Insurance Ombudsman within whose territorial

jurisdiction the branch or office of the insurer or the insurance broker, as the case may be, complained against or the residential address or place of residence of the complainant is located.

2. The complaint shall be in writing, duly signed or made by way of electronic mail or online through the website of the Council of Insurance Ombudsmen, by the complainant or through his legal heirs, Nominee or Assignee and shall state clearly the name and address of the complainant, the name of the branch or office of the insurer against whom the complaint is made, the facts giving rise to the complaint, supported by documents, the nature and extent of the loss caused to the complainant and the relief sought from the Insurance Ombudsman.
3. No complaint to the Insurance Ombudsman shall lie unless
  - a. the complainant has made a representation in writing or through electronic mail or online through website of the insurer or insurance broker concerned to the insurer or the insurance broker, as the case may be, named in the complaint and
    - i. either the insurer or the insurance broker, as the case may be, had rejected the complaint; or
    - ii. the complainant had not received any reply within a period of one month after the insurer or the insurance broker, as the case may be, received his representation; or
    - iii. the complainant is not satisfied with the reply given to him by the insurer or the insurance broker, as the case may be;
  - b. The complaint is made within one year—
    - i. after the order of the insurer or the insurance broker, as the case may be, rejecting the representation is received; or
    - ii. after receipt of decision of the insurer or the insurance broker, as the case may be, which is not to the satisfaction of the complainant;
    - iii. after expiry of a period of one month from the date of sending the written representation to the insurer or the insurance broker, as the case may be, if the insurer named fails to furnish reply to the complainant.
4. The Ombudsman shall be empowered to condone the delay in such cases as he may consider necessary, after calling for objections of the insurer or the insurance broker, as the case may be, against the proposed condonation and after recording reasons for condoning the delay and in case the delay is condoned, the date of condonation of delay shall be deemed to be the date of filing of the complaint, for further proceedings under these rules.
5. No complaint before the Insurance Ombudsman shall be maintainable on the same subject matter on which proceedings are pending before or disposed of by any court or consumer forum or arbitrator.
6. The Council for Insurance Ombudsmen shall develop a complaints management system, which shall include an online platform developed for the purpose of online submission and tracking of the status of complaints made under rule 14.

The Insurance Ombudsman shall not entertain complaints where the loss suffered by the complainant exceeds Rupees fifty lakhs.

**9 Appendix B: Section 39, Nomination by Policyholder**

Nomination of a life insurance Policy is as below in accordance with Section 39 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

1. The Policyholder of a life insurance on his own life may nominate a person or persons to whom money secured by the Policy shall be paid in the event of his Death.
2. Where the Nominee is a minor, the Policyholder may appoint any person to receive the money secured by the Policy in the event of Policyholder's Death during the minority of the Nominee. The manner of appointment to be laid down by the insurer.
3. Nomination can be made at any time before the maturity of the Policy.
4. Nomination may be incorporated in the text of the Policy itself or may be endorsed on the Policy communicated to the insurer and can be registered by the insurer in the records relating to the Policy.
5. Nomination can be cancelled or changed at any time before Policy matures, by an endorsement or a further endorsement or a will as the case may be.
6. A notice in writing of Change or Cancellation of nomination must be delivered to the insurer for the insurer to be liable to such nominee. Otherwise, insurer will not be liable if a bonafide payment is made to the person named in the text of the Policy or in the registered records of the insurer.
7. Fee to be paid to the insurer for registering change or cancellation of a nomination can be specified by the Authority through Regulations.
8. On receipt of notice with fee, the insurer should grant a written acknowledgement to the Policyholder of having registered a nomination or cancellation or change thereof.
9. A transfer or assignment made in accordance with Section 38 shall automatically cancel the nomination except in case of assignment to the insurer or other transferee or assignee for purpose of loan or against security or its reassignment after repayment. In such case, the nomination will not get cancelled to the extent of insurer's or transferee's or assignee's interest in the Policy. The nomination will get revived on repayment of the loan.
10. The right of any creditor to be paid out of the proceeds of any Policy of life insurance shall not be affected by the nomination.
11. In case of nomination by Policyholder whose life is insured, if the Nominees die before the Policyholder, the proceeds are payable to Policyholder or his heirs or legal representatives or holder of succession certificate.
12. In case Nominee(s) survive the person whose life is insured, the amount secured by the Policy shall be paid to such survivor(s).
13. Where the Policyholder whose life is insured nominates his
  - a. parents or
  - b. spouse or
  - c. children or
  - d. spouse and children
  - e. or any of themthe Nominees are beneficially entitled to the amount payable by the insurer to the Policyholder unless it is proved that Policyholder could not have conferred such beneficial title on the Nominee having regard to the nature of his title.
14. If Nominee(s) die after the Policyholder but before his share of the amount secured under the Policy is paid, the share of the expired Nominee(s) shall be payable to the heirs or legal representative of the nominee or holder of succession certificate of such Nominee(s).

15. The provisions of sub-section 7 and 8 (13 and 14 above) shall apply to all life insurance policies maturing for payment after 26.12.2014 the date when insurance law was amended.
16. If Policyholder dies after maturity but the proceeds and Benefit of the Policy has not been paid to him because of his Death, his Nominee(s) shall be entitled to the proceeds and Benefit of the Policy.
17. The provisions of Section 39 are not applicable to any life insurance Policy to which Section 6 of Married Women's Property Act, 1874 applies or has at any time applied except where a nomination is made in favour of spouse or children or spouse and children whether or not on the face of the Policy it is mentioned that it is made under Section 39. Where nomination is intended to be made to spouse or children or spouse and children under Section 6 of MWP Act, it should be specifically mentioned on the Policy. In such a case only, the provisions of Section 39 will not apply.

**10 Appendix C: Section 38, Assignment and Transfer of Insurance Policies**

Assignment or transfer of a Policy should be in accordance with Section 38 of the Insurance Act, 1938 as amended from time to time. The extant provisions in this regard are as follows:

1. This Policy may be transferred/assigned, wholly or in part, with or without consideration.
2. An Assignment may be effected in a Policy by an endorsement upon the Policy itself or by a separate instrument under notice to the Insurer.
3. The instrument of assignment should indicate the fact of transfer or assignment and the reasons for the assignment or transfer, antecedents of the assignee and terms on which assignment is made.
4. The assignment must be signed by the transferor or assignor or duly authorized agent and attested by at least one witness.
5. The transfer of assignment shall not be operative as against an insurer until a notice in writing of the transfer or assignment and either the said endorsement or instrument itself or copy there of certified to be correct by both transferor and transferee or their duly authorised agents have been delivered to the insurer.
6. Fee to be paid for assignment or transfer can be specified by the Authority through Regulations.
7. On receipt of notice with fee, the insurer should Grant a written acknowledgement of receipt of notice. Such notice shall be conclusive evidence against the insurer of duly receiving the notice.
8. If the insurer maintains one or more places of business, such notices shall be delivered only at the place where the Policy is being serviced.
9. The insurer may accept or decline to act upon any transfer or assignment or endorsement, if it has sufficient reasons to believe that it is
  - a. not bonafide or
  - b. not in the interest of the Policyholder or
  - c. not in public interest or
  - d. is for the purpose of trading of the insurance Policy.
10. Before refusing to act upon endorsement, the Insurer should record the reasons in writing and communicate the same in writing to Policyholder within 30 days from the date of Policyholder giving a notice of transfer or assignment
11. In case of refusal to act upon the endorsement by the Insurer, any person aggrieved by the refusal may prefer a claim to IRDAI within 30 days of receipt of the refusal letter from the Insurer.
12. The priority of claims of persons interested in an insurance Policy would depend on the date on which the notices of assignment or transfer is delivered to the insurer; where there are more than one instruments of transfer or assignment, the priority will depend on dates of delivery of such notices. Any dispute in this regard as to priority should be referred to Authority.
13. Every assignment or transfer shall be deemed to be absolute assignment or transfer and the assignee or transferee shall be deemed to be absolute assignee or transferee, except
  - a. where assignment or transfer is subject to terms and conditions of transfer or assignment OR
  - b. where the transfer or assignment is made upon condition that
    - i. the proceeds under the Policy shall become payable to Policyholder or Nominee(s) in the event of assignee or transferee dying before the insured OR
    - ii. the insured surviving the term of the Policy

Such conditional assignee will not be entitled to obtain a loan on Policy or surrender the Policy. This provision will prevail notwithstanding any law or custom having force of law which is contrary to the above position.

14. In other cases, the insurer shall, subject to terms and conditions of assignment, recognize the transferee or assignee named in the notice as the absolute transferee or assignee and such person
- a. shall be subject to all liabilities and equities to which the transferor or assignor was subject to at the date of transfer or assignment and
  - b. may institute any proceedings in relation to the Policy
  - c. obtain loan under the Policy or surrender the Policy without obtaining the consent of the transferor or assignor or making him a party to the proceedings
15. Any rights and remedies of an assignee or transferee of a life insurance Policy under an assignment or transfer effected before 26.12.2014, the date when insurance law was amended, shall not be affected by this section.

**11 Appendix D: Section 45, Policy shall not be called in question on the ground of mis-statement after three years**

Provisions regarding Policy not being called into question in terms of Section 45 of the Insurance Act, 1938, as amended from time to time are as follows:

1. No Policy of Life Insurance shall be called in question **on any ground whatsoever** after expiry of 3 yrs from
  - a. the date of issuance of Policy or
  - b. the Date of Commencement of Risk or
  - c. the date of revival of Policy or
  - d. the date of rider to the Policywhichever is later.

2. On the ground of fraud, a Policy of Life Insurance may be called in question within 3 years from
  - a. the date of issuance of Policy or
  - b. the Date of Commencement of Risk or
  - c. the date of revival of Policy or
  - d. the date of rider to the Policywhichever is later.

For this, the insurer should communicate in writing to the insured or legal representative or Nominee or assignees of insured, as applicable, mentioning the ground and materials on which such decision is based.

3. Fraud means any of the following acts committed by insured or by his agent, with the intent to deceive the insurer or to induce the insurer to issue a life insurance Policy:
  - a. The suggestion, as a fact of that which is not true and which the insured does not believe to be true;
  - b. The active concealment of a fact by the insured having knowledge or belief of the fact;
  - c. Any other act fitted to deceive; and
  - d. Any such act or omission as the law specifically declares to be fraudulent.
4. Mere silence is not fraud unless, depending on circumstances of the case, it is the duty of the insured or his agent keeping silence to speak, or silence is in itself equivalent to speak.
5. No Insurer shall repudiate a life insurance Policy on the ground of Fraud, if the Insured / beneficiary can prove that the misstatement was true to the best of his knowledge and there was no deliberate intention to suppress the fact or that such mis-statement of or suppression of material fact are within the knowledge of the insurer. Onus of disproving is upon the Policyholder, if alive, or beneficiaries.
6. Life insurance Policy can be called in question within 3 years on the ground that any statement of or suppression of a fact material to expectancy of life of the insured was incorrectly made in the proposal or other document basis which Policy was issued or revived or rider issued. For this, the insurer should communicate in writing to the insured or legal representative or Nominee or assignees of insured, as applicable, mentioning the ground and materials on which decision to repudiate the Policy of life insurance is based.
7. In case repudiation is on ground of mis-statement and not on fraud, the premium collected on Policy till the date of repudiation shall be paid to the insured or legal representative or Nominee or assignees of insured, within a period of 90 days from the date of repudiation. However, the payment will be as per IRDAI direction/Regulation/Circular from time to time.
8. Fact shall not be considered material unless it has a direct bearing on the risk undertaken by the insurer. The onus is on insurer to show that if the insurer had been aware of the said fact, no life insurance Policy would have been issued to the insured.

9. The insurer can call for proof of age at any time if he is entitled to do so and no Policy shall be deemed to be called in question merely because the terms of the Policy are adjusted on subsequent proof of age of life insured. So, this Section will not be applicable for questioning age or adjustment based on proof of age submitted subsequently.
